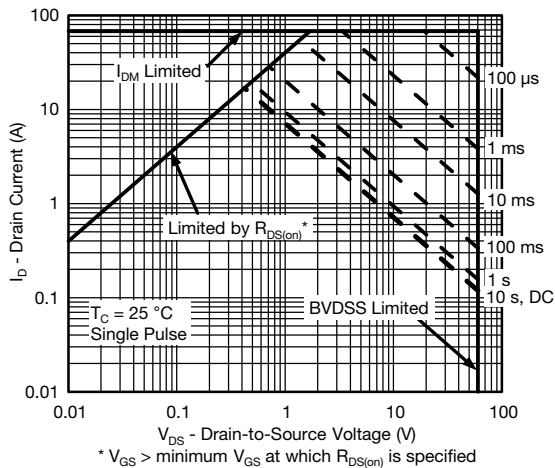

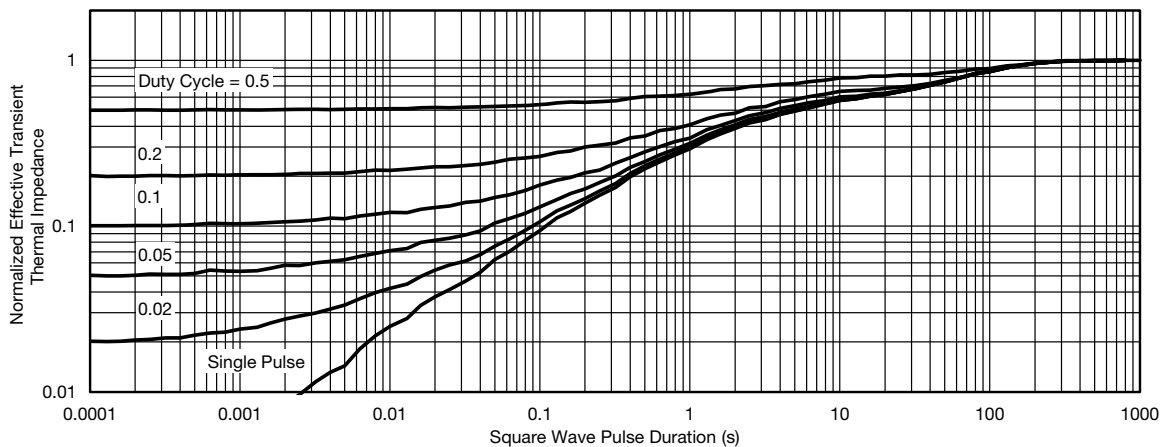

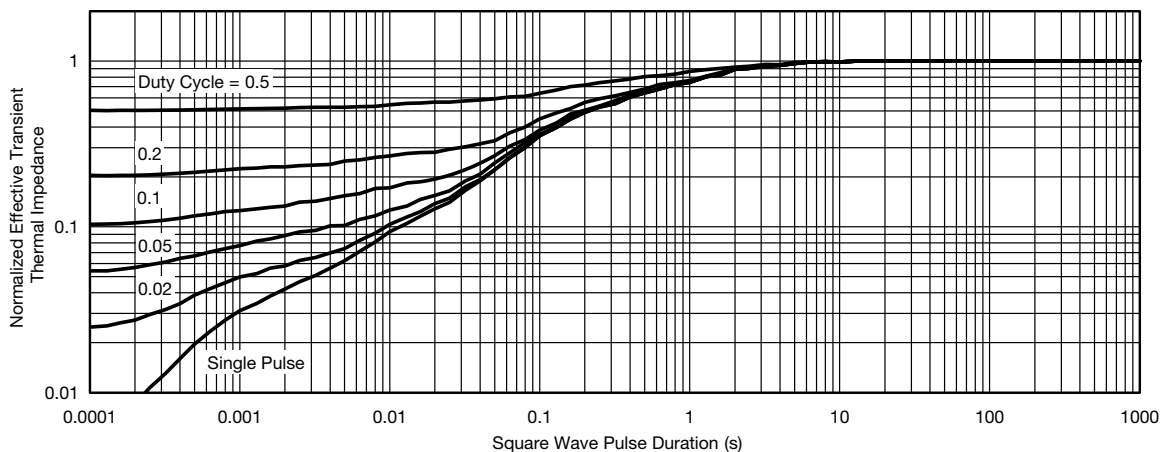


**Safe Operating Area**

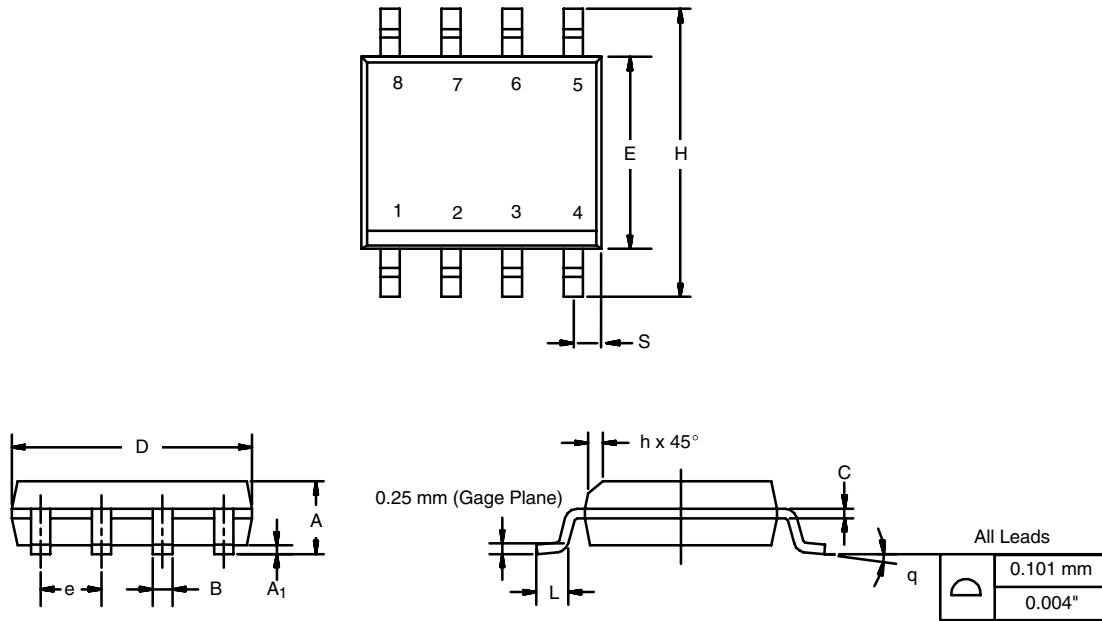
**Normalized Thermal Transient Impedance, Junction-to-Foot**

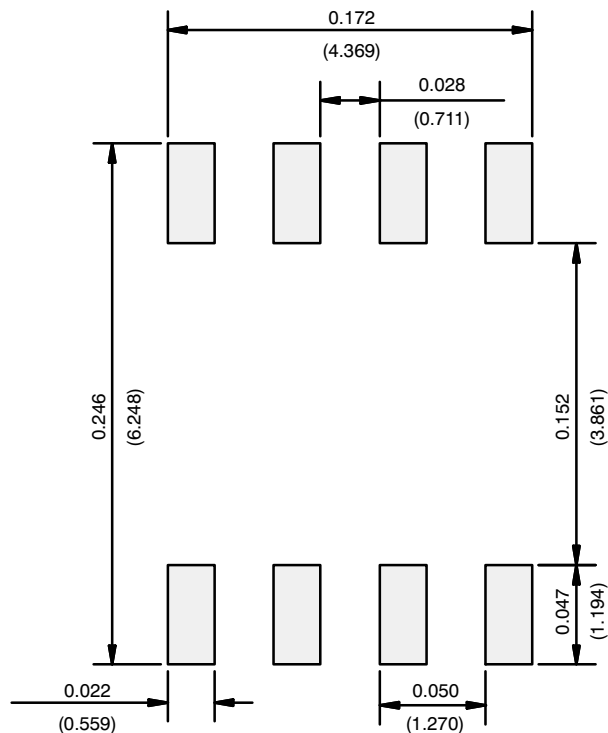
