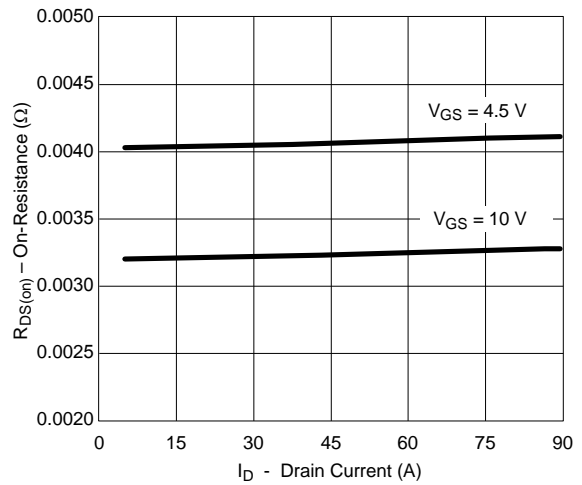

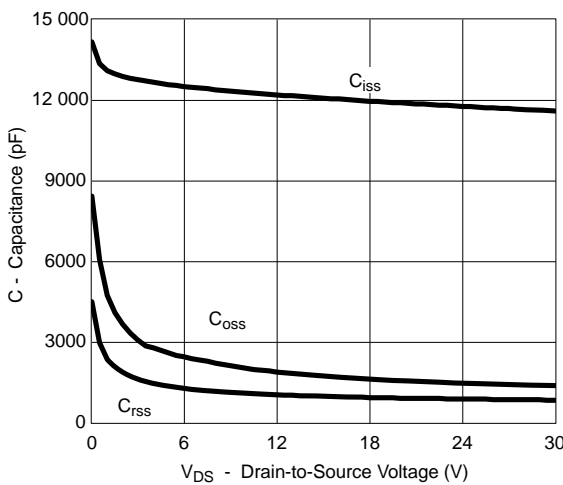

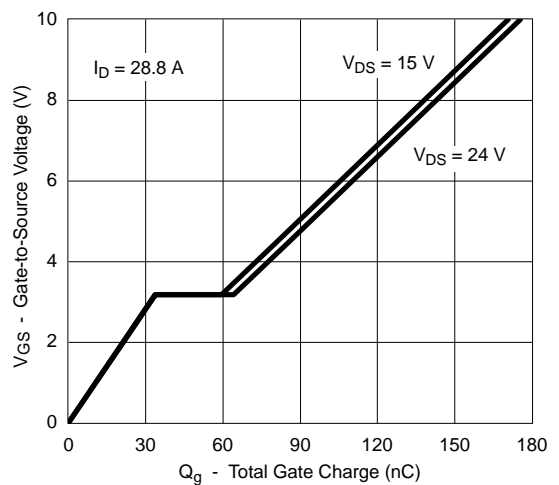
**Transconductance**



**$R_{DS(on)}$  vs. Drain Current**

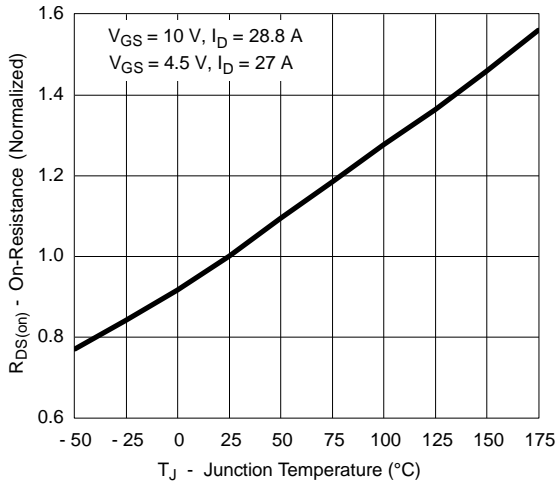

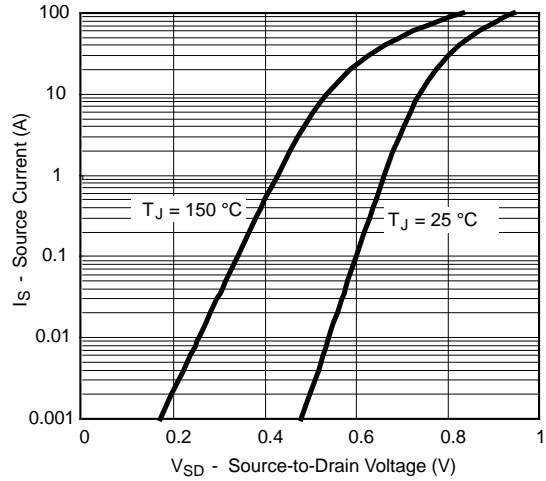

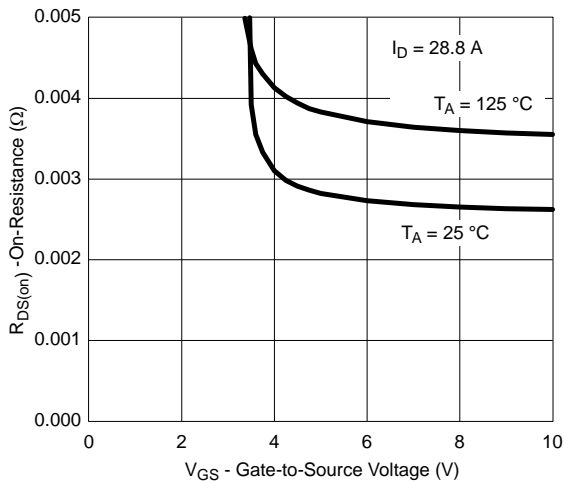

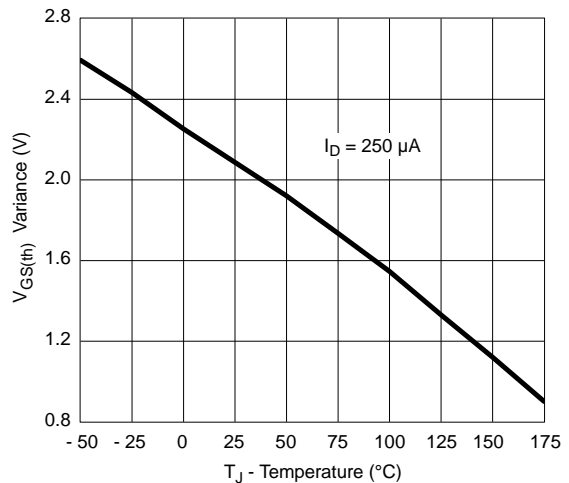
**On-Resistance vs. Junction Temperature**



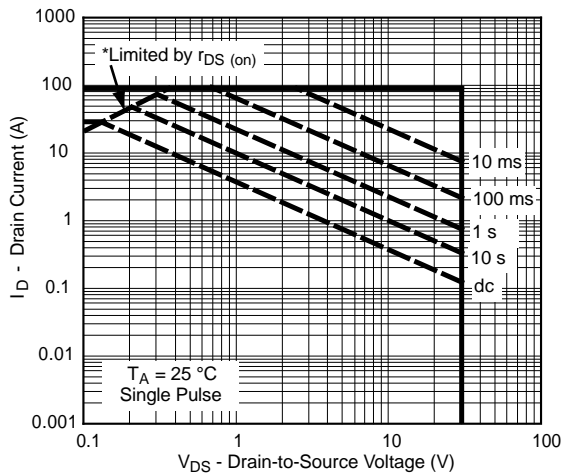
**Forward Diode Voltage vs. Temperature**



**$R_{DS(on)}$  vs.  $V_{GS}$  vs. Temperature**

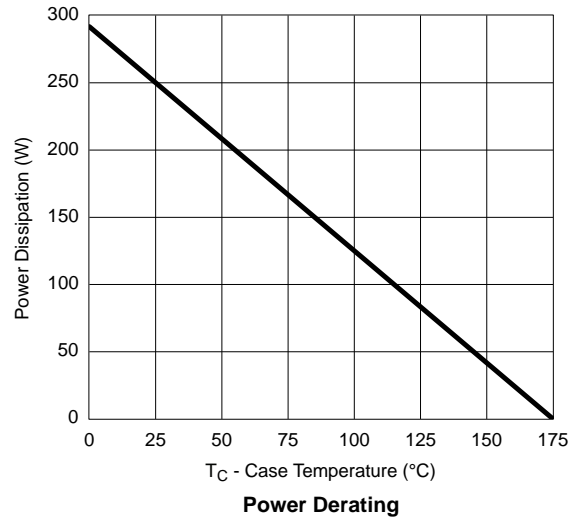
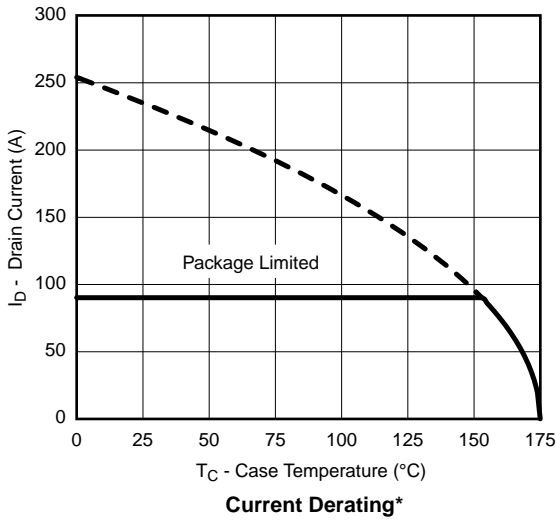
